Arlington Neighborhood Village (ANV) provides direct assistance to seniors aging in place as well as social support to foster connection and community engagement. 285+ volunteers deliver services including: rides to medical appointments, the grocery store, bank or post office; errands; friendly visits; tech help; and assistance accessing additional support. In 2023, 285 ANV volunteers fulfilled 4,095 services and gave 11,790 hours of their time. Volunteers drove a total of 43,820 miles at their own expense. 97% of member requests were filled. Hundreds of educational and social events were conducted with almost 5,000 participants.

ANV membership is open to Arlington adults aged 55 and up. ANV supports
