Since opening its doors to Arlington residents county-wide in 2014, Arlington Neighborhood Village (ANV) has expanded its membership to

220 adults ranging in age from 58 to 98. Annual membership fees are \$500 per person, \$750 for a household, with significantly

discounted membership available to those requiring financial assistance. By the end of 2019, over 19 percent of full members were

receiving financial assistance. Membership benefits include free transportation to medical appointments, grocery shopping, county

activities and ANV's wide array of social and educational programs. Members may also call for help with their computers, home

maintenance and yardwork. Many members enjoy the company of a regularly scheduled "friendly visitor," "walking buddy" or daily check-in

call. All services are provided by ANV volunteers who are trained, background checked, and insured. During 2019, more than 280

volunteers fulfilled 2,178 service requests, drove over 28,200 miles and dedicated 11,200 hours of service. ANV continues to design its

offerings based upon member needs and to combat social isolation. During 2019, ANV delivered more than 3,000 hours of social and

educational programming. 98% of members reported that they would recommend ANV to a neighbor or friend. Excerpts from ANV member

testimonials reflect the value of ANV: "The village is an answer to a prayer because I didn't want to go to a retirement community and

I didn't know how I was going to live on my own."; "Many thanks to the ANV Volunteer who took me grocery shopping this morning. He was

especially helpful in bringing up my groceries to my apartment because my arm is in a cast for a broken wrist."
